What is the overall Deductible ?	For In-Network Provider \$350 person/ \$700 family. For Out-of-Network Provider \$1,000 person/ \$2,000 family.	Generally, you must pay all of the costs from Providers up to the Deductible amount before this Plan begins to pay. If you have other family members on the Plan , each family member must meet their own individual Deductible until the total amount of Deductible expenses paid by all family members meets the overall family Deductible .
Are there services covered before you meet your Deductible ?	Yes. Pharmacy, services that require Copays , immunizations or In-Network hospice care and Preventive Care are covered before you meet your Deductible .	This Plan covers some items and services even if you haven't yet met the Deductible amount. But a Copayment or Cost Sharing may apply. For example, this Plan covers certain Preventive Services without cost-sharing and before you meet your Deductible . Does this plan provide Minimum Essential Coverage? Yes.
